

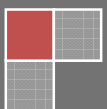

from Personal Appearance

UNDER SECTION 88

of The Registration Act

1. Chairman of the Board of Trustees for the Improvement of the City of Trivandrum

(Notification G.O.(Ms)No.654/62/RD, dated 26/07/1962)

In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Indian Registration Act 1908 (Act 10 of 1908), the Government of Kerala hereby direct that it shall not be necessary for the Chairman of the Board of Trustees for the Improvement of the City of Trivandrum to appear in person or by agent at any Registration Office, in any proceeding connected with the registration of any instrument executed by him or in his favour in his official capacity as the Chairman of the Board of Trustees for the Improvement of the City of Trivandrum or to sign as provided in Section 58 of the aforesaid Act.

Where any instrument is so executed the Registering Officer to whom such instrument is presented for registration may if he thinks fit, refer to the Chairman for information respecting the same and shall on being satisfied of the execution thereof register the instrument.

2. Official Receiver

(Notification G.O.(Ms)No.469/64/RD, dated 20/07/1964)

Under Clause (d) of Sub-section (1) of Section 88 of the Indian Registration Act 1908 (Act 10 of 1908), the Government of Kerala hereby specify the Office of any Official Receiver for the purposes of the said clause.

3. Deputy Rubber Production Commissioner, Kottayam

(Notification G.O.(Ms)No.653/64/RD, dated 30/09/1964)

In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88) of the Indian Registration Act, 1908 (Act 16 of 1908), the Government of Kerala hereby specify the office of the Deputy Rubber Production Commissioner, Kottayam as a public office where it shall not be necessary for the holder of such office to appear in person or by agent at any registration office in any proceeding connected with the registration of any instrument executed by him or in his favour in his official capacity or to sign as provided in Section 58 of the aforesaid Act.

4. Chairman of the Cochin Port Trust

(Notification G.O.(Ms)No.834/64/RD, dated 14/12/1964)

In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Indian Registration Act, 1908 (Central Act 16 of 1908), the Government of Kerala hereby direct that it shall not be necessary for the Chairman of the Cochin Port Trust to appear in person, or by agent at any Registration Office, in any proceeding connected with the registration of any

instrument executed by him or in his favour, in his official capacity as the Chairman of the Cochin Port Trust or to sign as provided in Section 58 of the aforesaid Act.

Where any instrument is so executed the Registering Officers to whom such instrument is presented for registration may if he thinks fit, refer to the Chairman for information respecting the same and shall on being satisfied of the execution (Notification thereof, register the instrument.

5. Senior Divisional Manager, Life Insurance Corporation of India

(Notification G.O.(Ms)No.933/65/RD, dated 22/12/1965)

In exercise of the powers conferred by Clause (d) of sub-section (1) of Section 88 of the Indian Registration Act, 1908 (Act 16 of 1908), the Government of Kerala hereby specify the office of the Senior Divisional Manager, Life Insurance Corporation of India, Trivandrum as a public office for the purpose of Section 88 of the said Act.

6. Zonal Manager/Deputy Zonal Manager, Life Insurance Corporation of India

(Notification G.O.(Ms)No.125/66/RD, dated 28/02/1966)

In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Indian Registration Act, 1908 (Act 16 of 1908), the Government of Kerala hereby specify the office of the Zonal Manager/Deputy Zonal Manager, Life Insurance Corporation of India, Southern Zone, Madras as a public office for the purpose of Section 88 of the said Act.

7. Chairman, Kerala State Electricity Board

(Notification G.O.(Ms)No.679/66/RD, dated 12/12/1966)

In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Indian Registration Act, 1908 (Act XVI of 1908), the Government of Kerala hereby specify the office of the Chairman, Kerala State Electricity Board, Trivandrum as a public office for the purpose of Section 88 of the said Act.

8. Chairman, Rubber Board

(Notification G.O.(Ms)No.126/68/RD, dated 24/02/1968)

In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Indian Registration Act, 1908 (Act 16 of 1908), the Government of Kerala hereby specify the office of the Chairman, Rubber Board, Kottayam as a to public office where it shall not be necessary for the holder of such office to appear in person or by agent at any Registration Office in any proceeding connected with the registration of any instrument executed by him or in his favour in his official capacity or to sign as provided in Section 58 of the aforesaid Act.

9. Registrar, University of Kerala

(Notification G.O.(Ms)No.481/69/RD, dated 22/09/1969)

In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Indian Registration Act, 1908 (Act XVI of 1908), the Government of Kerala hereby specify the Office of the Registrar of University of Kerala, Trivandrum for the purposes of the said section.

10. Regional Provident Fund Commissioner of Kerala

(Notification G.O.(Ms)No.49/72/RD, dated 09/06/1972)

In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Registration Act, 1908 (Central Act 16 of 1908) the Government of Kerala hereby direct that it shall not be necessary for the Regional Provident Fund Commissioner of Kerala to appear in person or by agent at any Registration Office, in any proceeding connected with the registration of any instrument executed by him or in his favour, in his official capacity as the Regional Provident Fund Commissioner of Kerala or to sign as provided in Section 58 of the aforesaid Act.

Where any instrument is so executed, the Registering Officer to whom such instrument is presented for registration may if he thinks fit, refer to the Regional Provident Fund Commissioner for information respecting the same and shall, on being satisfied to the execution thereof register the instrument.

11. Executive Trustee, Cochin Town Planning Trust

(Notification G.O.(Ms)No.98/73/TD, dated 09/08/1973 in K.G.No.37, dated 18/09/1973)

SRO No.565/73.— In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Registration Act, 1908 (Central Act 16 of 1908), the Government of Kerala hereby specify the office of the Executive Trustee, Cochin Town Planning Trust as a public office for the purposes of Section 88 of the said Act.

12. General Manager, Kerala State Road Transport Corporation

(Notification G.O.(Ms)No.137/74/TD, dated 19/11/1974 in K.G.No.52, dated 24/12/1974)

SRO No.945/74.— In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Registration Act, 1908 (Central Act 16 of 1908), the Government of Kerala hereby specify the Office of the General Manager, Kerala State Road Transport Corporation, as a public office for the purposes Of Section 88 of the said Act.

Explanatory Note

(This note does not form part of the Notification but is intended to explain its general purport)

The General Manager, Kerala State Road Transport Corporation has requested Government to exempt him from personal appearance to admit the execution of the Release Deed in connection with the House Building Advance sanctioned to the employees of the Kerala State Road Transport Corporation, under section 88 of the Indian Registration Act, as it is not practically possible for him to appear before the Sub Registrars in person for the execution of each and every release deed.

This notification is intended to sanction the above request.

13. Director, Central Plantation Crops Research Institute

(Notification G.O.(Ms)No.129/76/TD, dated 12/10/1976 in K.G.No.42, dated 26/10/1976)

SRO No.1078/76.— Under Clause (d) of Sub-section (1) of Section 88 of the Registration Act, 1908 (Central Act 16 of 1908), the Government of Kerala hereby specify the Office of the Chairman of the Indian plantation crops Research Institute, Kasaragod, for the purposes of the said section.

Explanatory Note

(This note does not form part of the Notification but is intended to indicate its general purport.)

Employees of the Central Plantation crops Research Institute, Kasaragod who are sanctioned house building advance have to mortgage the land in which houses are proposed to be constructed in favour of the Indian Council of Agricultural Research by registering documents, in which the Director of the said Indian of the Institute is a party. Due to preoccupations and frequent tours it has become difficult for the Director of the Institute to make personal appearance in registering offices to get such documents registered.

The above notification is intended to exempt him from making personal appearance in the registering office for this purpose in his official capacity as Director of the Institute.

14. Secretary, Greater Cochin Development Authority

(Notification G.O.(Ms)No.130/76/TD, dated 14/10/1976 in K.G.No.42, dated 26/10/1976)

SRO No.1079176.— In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Registration Act, 1908 (Central Act 16 of 1908), and in supersession of notification No.G.O.(Ms.)98/73/TD, dated the 9th August, 1973, published as SRO No.565/73 in Kerala Gazette No.37 dated the 18th September, 1973, the Government of Kerala hereby specify the Office of the Secretary, Greater Cochin Development Authority, as a public office for the purposes of Section 88 of the said Act.

Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

Government have issued orders exempting the Executive Trustee of the erstwhile Cochin Town Planning Trust from personal appearance in Sub Registry Offices under Section 88 of the Registration Act as per notification issued under G.O.(Ms.)No.98/73/TD, dated 09/08/1973. The Secretary, Greater Cochin Development Authority has reported that Government have constituted the Greater Cochin Development Authority as a successor body of the Cochin Town Planning Trust and has requested that he may therefore be exempted from personal appearance in the Sub Registry Offices under Section 88 of the Registration Act.

The above notification is intended to exempt him from making personal appearance in the Sub Registry Offices in his official capacity as Secretary of the Greater Cochin Development Authority.

15. Divisional Manager, Life Insurance Corporation of India

(Notification G.O.(Ms)No.239/79/TD, dated 14/03/1979 in K.G.No.14, dated 03/04/1979)

SRO No.385/79.— In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Registration Act, 1908 (Central Act 16 of 1908), the Government of Kerala hereby specify the Office of the Divisional Manager, Life Insurance Corporation of India, Kozhikode, as a public office for the purpose of the said section.

Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

As a time when there was only one Division namely, Trivandrum Division in this State for the Life Insurance Corporation of India, Government as per notification G.O.(Ms.) No.933/65/RD, dated 22/12/1965 specified the office of the Divisional Manager, Trivandrum as a public office for the purpose of Section 88 of the Registration Act, so as to exempt him or his agent from personal appearance in registration offices for registering documents. From 1972

onwards another Division viz., Kozhikode Division has been formed in this State for the Life Insurance Corporation of India. The Divisional Manager of this Division has requested that similar orders may be issued in respect of his office also. Government propose to sanction this request.

This notification is intended to achieve the above object.

16. Area Managers, Food Corporation of India

(Notification G.O.(Ms)No.102/82/TD, dated 11/02/1982 in K.G.No.34, dated 24/08/1982)

SRO No.318/82.— In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Registration Act, 1908 (Central Act 16 of 1908), the Government of Kerala hereby specify the Offices of the Area Managers, Food Corporation of India, as a public offices for the purpose of the said section.

Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

The Regional Manager, Food Corporation of India, Trivandrum has requested to exempt all District Managers of Food Corporation of India from personal appearance in registration offices for registering documents for securing House Building Advance by the Employees. Government propose to sanction this request.

The above notification is intended to achieve this purpose.

17. Chief Accounts Officer, Kerala State Road Transport Corporation

(Notification G.O.(Ms)No.44/82/TD, dated 29/07/1982 in K.G.No.37, dated 21/09/1982)

SRO No.999/82.— In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Registration Act, 1908 (Central Act 16 of 1908), and in supersession of notification No.G.O.(Ms.)137/74/TD, dated the 19th November, 1974, published as SRO No.945/74 in Part I of the Kerala Gazette No.52 dated the 24th December, 1974, the Government of Kerala hereby specify the Office of the Chief Accounts Officer, Kerala State Road Transport Corporation, as a public office for the purposes of the said Section.

Explanatory Note

The KSRTC proposes to delegate the power of executing Release Deeds, etc., in respect of House Building Advance sanctioned to the employees of the Corporation, to the Chief Accounts Officer of the Corporation. The Corporation has therefore requested to substitute the words "General Manager" in the notification in G.O.(Ms)137/74/TD, dated 19/11/1974 by the words "Chief Accounts Officer".

The notification is intended to sanction the above request.

18. Director, Central Institute of Fisheries Technology

(Notification G.O.(Ms)No.53/82/TD, dated 26/08/1982 in K.G.No.37, dated 21/09/1982)

SRO No.1110/82.— In exercise of the powers conferred by Clause (d) of Sub-section (1) of Section 88 of the Registration Act, 1908 (Central Act 16 of 1908), the Government of Kerala hereby specify the Office of the Director of Central Institute of Fisheries Technology, Cochin, as a public office for the purposes of the said Section.

Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

The Director, Central Institute of Fisheries Technology, has requested to exempt him from personal appearance in registration offices for executing re-conveyance deeds of the mortgage properties to the staff of the institute on repayment of the Principal House Building Advances and interest. Scheduled Castes and Scheduled Tribes Limited, Trichur, as a public office for the purposes of the said section.
